In computing the amount of Federal gift tax to be paid on a gift or the amount of Federal estate tax to be paid at death, the gift and estate tax provisions of the Internal Revenue Code (Code) apply a unified rate schedule to the taxpayer's cumulative taxable gifts and taxable estate on death to arrive at a net tentative tax.

Under the new law, the federal estate, gift and generation-skipping transfer (â€œGSTâ€•) tax exemption amounts will increase to \$11,200,000 for individuals and \$22,400,000 for married couples, from \$5,490,000 and \$10,980,000, respectively, in 2017.

## **2018 Estate, Gift and GST Tax Exemption Increases and**

Qualified income will be taxable at 80% of the normal tax bracket rate on other business income Applies to the lesser of 20% of business income or 50% of total wages paid by the business Specifically excludes certain types of professional service and investment income.

### **Estate Tax - AICPA**

A federal tax law allows each to give up to \$15,000 to one individual without incurring federal gift taxes. The federal gift tax limit is increasing to \$15,000 in 2018. This exemption is tied to inflation, but can only increase to the nearest \$1,000 amount.

### **Federal Estate Tax and Gift Tax Limits Announced For 2018**

The Federal estate and gift taxes, as discussed in chapter 3, are excise taxes that generally are levied on the fair market value (FMV) of property that is gratuitously transferred.
